It is the intent that Financial Assistance will be granted only for Spring 2024 Registration Fee.

In the event that no Financial Assistance is granted, the parent/applicant will be notified and required to pay the remaining balance due of the Recreation Registration Fee before their child/player can be placed on a team.

Instructions: Financial Assistance Applications must be submitted prior to January 15, 2024. NO APPLICATIONS WILL BE REVIEWED AFTER THIS DATE. Financial Assistance will be granted on a rolling basis until the allotment is expended. Therefore, the earlier the Financial Assistance Application is received, the better the possibility the request will be granted. (Be prepared to meet with the Scholarship Committee if questions arise.) The parent/applicant will be notified of the Scholarship Committee's decision.
